# **Notice of Annual General Meeting for 2024**

Notice is hereby given that U3A Beachmere Inc will hold its Annual General Meeting as follows:

U3A Beachmere is moving into its 6th year of operation and for the most part proving very successful. Over this period, we have offered numerous interesting and creative courses. Our financial position is sound, and whilst not being profit focused, we have approximately \$19,000 in the bank which is being used to support our community services.

As at Term 1, 2024 the number of memberships and course enrolments are continuing to decline when compared to previous years. Despite a concentrated effort by the Committee to encourage more participation, our numbers are not increasing.

Our single greatest challenge however is the capacity to maintain an effective Management Committee. U3A requires six (6) people at any one time to plan, coordinate and deliver its services.

These positions include:

- President
- Secretary
- Treasurer
- Tutor/Course Coordinator
- Volunteer Coordinator
- Communications & Publicity Coordinator

Full position descriptions are available on the drop down list under the AGM 2024 menu button.

Reliance on the same committee representatives to continue undertaking these roles is NOT a sustainable solution. Failure to attract new committee members will unfortunately result in U3A Beachmere failing, and future classes being abolished.

If new committee representation is not found before the end of the current term (28 March 2024) a special mid-year meeting will need to be called where two (2) motions will be put for approval.

1. To dissolve U3A Beachmere Inc and advise all relevant parties, including the Qld Office of Fair Trading, and U3A Network accordingly.

2. To distribute U3A Beachmere Inc assets to other local community or service organisations.

Members are urged to attend this critical meeting, however those unable to participate on the day may exercise their right to vote via a Proxy.

Members are asked to consider nominating for a position on the Management Committee. Nomination Forms are available from the office, and online <u>U3A</u> <u>Beachmere Website</u> or nominations can be taken on the day of the AGM.
